

TERMS OF SERVICE FOR EVENTS

These Terms of Service for Events (these "**Terms**") shall govern your ("**You**" or "**Your**" or "**Yourself**") attendance of or participation in, any online events and webinars hosted or organized by Prodalim Group ("**We**" or "**Us**" or "**Prodalim**") (each, as applicable, an "**Event**"). **By attending or participating in an Event You agree to be bound by these Terms.**

You agree that We may change any part of an Event, including its content, at any time or discontinue an Event or any part thereof, for any reason, without notice to You and without liability. You declare that by acceptance of these Terms and/or by attending or participating in an Event, You are of legal age to form a binding contract with Prodalim. If You are agreeing to be bound by these Terms on behalf of Your employer or other person or entity or are otherwise attending or participating in an Event on behalf of Your employer or other person or entity, You represent and warrant that You have full legal authority to attend or participate in the applicable Event on behalf of Your employer or such person or entity (as applicable) and to bind Your employer or such person or entity (as applicable) to Your actions and to these Terms **and in such case each reference to "You" or "Your" or "Yourself" in these Terms will also include Your employer or other person or entity, as applicable.** If, (i) You do not have the requisite authority, You may not accept these Terms or attend or participate in any Event on behalf of Your employer or other person or entity, as applicable; and (ii) at some point You do not/cease to have the requisite authority to bind Your employer or other person or entity, as applicable, to Your actions, then immediately thereafter You shall notify Prodalim in writing and You may not (and must refrain from any) further attend or participate in any Event on behalf of Your employer or other person or entity, as applicable. You may not attend or participate in any Event and may not accept these Terms if You are a person barred from attending or participating in Events under the laws of the country in which You are a resident or from which You attend or participate in the applicable Events.

We may, in our sole discretion, at any time without notice, (i) refuse to allow the attendance of or participation in any Event (in whole or in part) to any person or entity; (ii) refuse to approve and/or cancel or terminate any Event registration (in whole or in part) of any person or entity; (iii) bar any person or entity from attending and participating in all or any part of any Event (or any or all other Events), and refuse to provide any person or entity with access to Events Materials (as defined below), in whole or in part; (iv) change (in whole or in part) any Event and/or any Event's program, including, without limitation, its content; and/or (v) limit the number of Event attendees and participants.

We may as well, at any time without notice and in our sole discretion, terminate Your right to attend or participate in any Event, or any portion thereof, and block or prevent Your future attendance of or participation in any Event or any portion thereof.

If You violate these Terms, Prodalim reserves the right to issue You a warning regarding the violation or to immediately terminate or suspend Your attendance of and/or participation in any Event or any portion thereof. You agree that Prodalim does not need to provide You with a notice before terminating or suspending Your attendance of and/or participation in an Event or any portion thereof, but it may provide such notice in its sole discretion.

way of reference, and, to the maximum extent permitted by law, by attending or participating in an Event You agree to be bound by its terms and conditions. Unless the context otherwise specifically requires, all reference herein to these Terms, shall also include the Privacy Policy. **We advise You to carefully read the Privacy Policy.** You acknowledge and agree that between You and Prodalim, only You are responsible for the accuracy and content of Your personal information, and You agree to keep it up to date.

1. Attendance of and Participation in Events

It is Your responsibility to ensure Your computer or mobile device meets all the necessary technical specifications to enable You to attend and participate in the Event. Prodalim does not provide You with the equipment to attend and participate in any Event. You are responsible for all fees charged by third parties related to Your attendance of and participation in an Event (e.g., charges by internet service providers or air time charges). Your attendance of and participation in any Event are subject to (i) these Terms;

(ii) any additional terms posted during, via and/or on the applicable Event; and (iii) any additional terms You agree to in connection with the applicable Event and/or the attendance of and participation in the applicable Event and/or the applicable Event registration.

You are exclusively responsible for maintaining the confidentiality of Your username, screen name, password, account and/or Event registration information which are personal and You are fully and exclusively responsible for all activities that occur under Your name, username, screen name, password, account or Event registration. Only You may attend and participate in the applicable Event and You may not share or distribute to a third party any username, screen name, password or Event registration information for attending or participating in any Event. Prodalim may permit You to transfer Your registration of certain Events to another person, corporation, partnership or other entity with which You are associated, at Prodalim's discretion, subject to its applicable transfer and cancellation policies, as may be amended from time to time. Each transfer or cancellation request for an applicable Event must be submitted in writing through events@prodalim.com and will be processed based on the time and date that the request was submitted. No refund or credit for a registration cancellation will be issued if You fail to submit a cancellation request in accordance with these requirements. For clarity, failure to check in at an Event does not constitute cancellation, and will not give rise to a refund or a credit. Session enrollments, trainings and certifications are not transferable.

2. Changes to Events

Events are subject to change at any time, without notice. Prodalim does not guarantee the attendance of any third party (including, without limitation, any exhibitor or speaker), or that any scheduled session, keynote or other activity will take place.

Prodalim reserves the right, including without prior notice, to make any change to an Event program at any time for any reason (including, without limitation, modification of the schedule or content of, or cancellation of, any session, keynote or other activity). Prodalim is not responsible for, and no reimbursement will be issued in the event of, any change to an Event (including, without limitation, modification of the overall Event program, or the schedule or content of, or cancellation of, any session, keynote or other activity).

3. User Content

You agree that any content published or shared by You (or anyone on Your behalf) through, during or in connection with any Event or in connection with Your attendance of and/or participation in Events is done so through the use of technology and tools provided by Prodalim. You agree that You are publishing and sharing such content willingly and You represent that You own such content or have received the necessary authorizations from

third parties, that You have all rights to publish and share said content and that publishing and sharing of the content by You complies with all applicable laws. You grant Prodalim the right to act as an agent on Your behalf as the Event's operator.

Prodalim does not claim ownership of any videos, data, text, graphics, photographs, or any other content, and their selection and arrangement, provided or shared by any user in connection with such user's attendance of and/or participation in an applicable Event (collectively, the "**User Content**"). However, by sending and/or creating and/or sharing and/or uploading and/or publishing User Content and/or attending or participating in an applicable Event You automatically grant Prodalim a non-exclusive, royalty-free, perpetual license of all worldwide rights to share, use, edit, modify, include, incorporate, adapt, record and reproduce such User Content, including, without limitation, all trademarks associated therewith, in any manner whatsoever, in or out of context, in all languages, in all media now known or hereafter, including for the avoidance of doubt commercial, non-commercial and/or promotional use by Prodalim. Prodalim may retain any raw material that You submit, and make internal use of such material including for testing purposes. You hereby agree that any of Prodalim's users may view and use the User Content.

Prodalim may or may not regulate User Content and provides no representations or guarantees regarding the accuracy, quality, or integrity of any User Content posted during or via any Event. By attending or participating in an applicable Event You acknowledge and accept that You may be exposed to material You find offensive or objectionable. To the maximum extent permitted by law, You agree that Prodalim will not under any circumstances be responsible or liable for any User Content, including, but not limited to, errors in any User Content or any loss or damage incurred by use of the User Content or for any failure to or delay in removing User Content or any loss or damage to User Content.

Prodalim reserves the right (but shall at no time be obligated) to, in its sole discretion, remove, block, edit, move, disable or permanently delete User Content from any Event with or without notice for any reason whatsoever. You hereby agree that, to the maximum extent permitted by applicable law, Prodalim shall at no time be responsible or held liable for the presence, removal, modification or blocking of material or User Content that may be considered offensive and shall at no time be obligated to effect such removal other than under applicable law.

4. Rules of Conduct and Usage

You represent and warrant that You have full right and legal authority to attend and participate in the applicable Event and to be bound by these Terms. You agree that You will comply fully with these Terms and all applicable domestic and international laws, regulations, statutes, ordinances that govern Your attendance of or participation in an applicable Event and/or the transmission of technical data exported from the country in which You reside. Without limiting the foregoing and in recognition of the global nature of the internet, You agree to comply with all local and international rules regarding online conduct. You also agree to comply with all applicable laws affecting the transmission of content or the privacy of persons.

You undertake that You shall not defraud, or attempt to defraud, Prodalim or other users, and that You shall not act in bad faith in Your attendance of and participation in an applicable Event. If Prodalim determines that You have acted in bad faith and/or in violation of these Terms, or if Prodalim determines that Your actions fall outside of reasonable community standards, Prodalim may, at its sole discretion, prohibit You from attending and/or participating in any Event or any portion thereof. You agree that Your attendance of and participation in any Event shall be lawful and that You will comply with the usage rules. In furtherance of the foregoing, and as an example and not as a limitation, You agree that You shall not:

- Attend or participate in an Event if You are barred under the provisions of these Terms or any applicable law;
- Attend or participate in an Event on behalf of Your employer or other person or entity if You do not have full legal authority to bind Your employer or such person or entity (as applicable) to Your actions;
- Promote, host or display any Event on any websites that: (i) contain indecent, obscene or pornographic material, hate speech, highly explosive subject matter (as determined by Prodalim at its sole discretion), defamatory, libelous, obscene, gambling related, discriminatory, deceptive, abusive spyware, adware, or other malicious programs or code, unsolicited mass distribution of email, or any illegal subject matter or activities or otherwise offensive content, or content addressed to individuals under the age of 18; (ii) incorporate any materials that infringe or assists others to infringe on any copyright, trademark or other intellectual property rights; (iii) are an incentive-based website, such as a lottery or sweepstakes site which rewards users for clicking on links; (iv) engage in activities that violate Prodalim's Privacy Policy; or (v) infringe any right of any third party or violate any applicable law or regulation;
- Upload, post, transmit or otherwise disseminate any material and/or make or present any statement that is vulgar, indecent, obscene, pornographic, sexual or that is, in a reasonable person's view, otherwise offensive or objectionable;
- Libel, ridicule, defame, mock, stalk, intimidate, threaten, harass, or abuse anyone, hatefully, racially, ethnically or in any other manner;
- Copy, rent, lease, sell, transfer, assign, sublicense, disassemble, reverse engineer or decompile (except if expressly authorized by Prodalim or by applicable statutory law), modify or alter any part of any Event;
- Upload or transmit (or attempt to upload or transmit) files that contain viruses, Trojan horses, worms, time bombs, cancelbots, corrupted files or data, or any other similar software or programs that may damage the operation of any Event or the computers of other users attending or participating in any Event;
- Advertise, solicit or transmit any commercial advertisements, including chain letters, junk e-mail or repetitive messages (spim or spam) to anyone;
- Violate the contractual, personal, intellectual property or other rights of any party including by using, uploading, transmitting, distributing, or otherwise making available any information or material made available during or through any Event in any manner that infringes any copyright, trademark, patent, trade secret, or other right of any party (including rights of privacy or publicity);
- Create false personas, multiple identities, use bots or other automated software programs to defraud or which otherwise violate these Terms and/or the terms of service of any third-party applications or social networks through which the applicable Event is accessed;
- Upload or transmit (or attempt to upload or to transmit), without Prodalim's express consent, any material that acts as a passive or active information collection or transmission mechanism, including, without limitation, clear graphics interchange formats ("gifs"), 1x1 pixels, web bugs, cookies or other similar devices (sometimes referred to as "spyware", "passive collection mechanisms" or "pcms");
- Improperly use support channels or complaint buttons to make false reports to Prodalim;
- Develop and distribute "auto" software programs, "macro" software programs or other "cheat utility" software programs or applications;
- Encourage any third party to: (i) directly or indirectly generate usage, queries, impressions, or clicks through any automated, deceptive, fraudulent or other invalid means; (ii) edit or modify any tag, or remove, obscure or minimize any tag in any way; or (iii) engage in any action or practice that reflects poorly on Prodalim or otherwise disparages or devalues Prodalim reputation or goodwill;
- Make representations with respect to Prodalim not approved in advance and in writing by Prodalim. You shall obtain Prodalim's prior written approval to the content of any marketing message, and with respect to any use of Prodalim's trade name and/or trademarks and/or designs in connection with any Event;

- Engage in any fraudulent activity with respect to payment methods or advertiser tracking mechanisms;
- Attempt to interfere with, hack into or decipher any transmissions to or from the servers for any Event; and/or
- Interfere with the ability of others to enjoy attending and participating in any Event, including, without limitation, disruption, overburden or aid the disruption or overburdening of any Event's servers, or take actions that interfere with or materially increase the cost to provide an applicable Event for the enjoyment of all its users.

5. Government Employees and Officials

If You are a government employee or official, You must identify Yourself as such during the registration process for an Event.

If You are a government employee or official and You are offered free or discounted attendance of or participation at an Event, You must disclose Your attendance of the Event to Your employing government agency in advance, and obtain such agency's permission for You to accept free or discounted attendance of such Event. You must also confirm Your compliance with the foregoing upon request by Prodalim.

If You are a government employee or official, You must also comply, for the entire duration of the applicable Event, with all applicable rules and regulations imposed by Your employing agency, including, without limitation, those rules and regulations relating to the acceptance and disclosure of gifts and gratuities.

6. Intellectual Property Ownership

Without derogating from any other terms herein, Prodalim and/or its parent companies, subsidiaries and affiliates retain all rights in any Events materials (including, but not limited to, applications, software, designs, graphics, texts, information, pictures, video, sound, music, and other files, and their selection and arrangement) (collectively, "**Events Materials**"). The entire contents of any Event are protected by applicable copyright, trade dress, patent, and trademark laws, international conventions, and other laws protecting intellectual property and related proprietary rights. You shall not, nor shall You cause any other party to modify, decompile, disassemble, reverse engineer, copy, transfer, create derivative works from, rent, sub-license, distribute, reproduce framed, republish, scrape, download, display, transmit, post, lease or sell in any form or by any means, in whole or in part, use for any purpose other than for attending and participating in the applicable Event pursuant to these Terms or otherwise exploit any of the Events Materials without Prodalim's explicit, prior written consent. All other uses of copyrighted or trade mark material, including any derivative use, require explicit, prior written consent from Prodalim. Any reproduction or redistribution of materials not in accordance with these Terms is explicitly prohibited and may result in severe civil and criminal penalties.

Prodalim's and/or its licensors, parent companies, subsidiaries and affiliates own all right, title, and interest, including, without limitation, copyrights and other intellectual property rights, in and to all the Events Materials. You hereby acknowledge that You do not acquire any ownership rights by attending or participating in an applicable Event or by accessing any of the Events Materials, or rights to any derivative works thereof.

You are not required to provide Prodalim with any feedback or suggestions regarding any Event or any of the Events Materials. However, should You provide Prodalim with comments or suggestions for the modification, correction, improvement or enhancement of any Event and/or any of the Events Materials, then, subject to the terms and conditions of these Terms, You hereby grant Prodalim a non-exclusive, irrevocable, perpetual, worldwide, royalty-free license, including the right to sublicense, to use and disclose such comments and suggestions in any manner Prodalim chooses and to display, perform, copy, have copied, make, have made, use,

sell, offer to sell, and otherwise dispose of Prodalim's and its sublicensees' products and content embodying such comments or suggestions in any manner and via any media Prodalim chooses, but without reference to the source of such comments or suggestions.

7. Personal Release

Prodalim (and/or others on behalf of Prodalim) may be photographing, recording (both audio and video), webcasting, podcasting or otherwise transmitting during any or all of an Event (including at the Event venue during an Event session, keynote or other activity). Your image, likeness, voice, statements and other identifying characteristics (each, an "**Image**") may be captured in photographs, recordings (both audio and video), webcasts, podcasts, or other transmissions of the Event (each, a "**Recording**").

You hereby grant to Prodalim a worldwide, royalty-free, fully paid-up, non-exclusive, perpetual, irrevocable, transferable and fully sublicensable (through multiple tiers) license, without additional consideration to You or any third party, to reproduce, distribute, perform and display (publicly or otherwise, create derivative works of, adapt, modify and otherwise use, analyze and exploit Recordings (including Your Images therein), in whole or in part, in any format or media now known or hereafter developed, and for any purpose (including for promotional purposes, such as (but not limited to) testimonials).

Prodalim exclusively owns all right, title and interest (including intellectual property rights) in and to the Recordings (including Your Images therein), all modifications and derivatives of Recordings (including Your Images therein), and all proceeds derived therefrom. Prodalim has no obligation to share any such proceeds with You.

You hereby irrevocably waive any right You may have to inspect or approve the use or other exploitation of any Recording (including your Images therein) or any reproductions thereof, and You agree that Prodalim has no obligation to use any Recording (including any of Your Images) or otherwise exercise any of the rights granted to Prodalim with respect to any Recording (including any of Your Images).

Your Images may appear in Recordings made available to the public, and third parties may retain, use or distribute such Recordings. Once made available to the public, Prodalim has no control over, and is not responsible for, any use or misuse (including any distribution) by any third party of Recordings (including Your Images therein).

In connection with the use or other exploitation of Recordings (including Your Images), You hereby irrevocably waive and release any and all claims with respect to intellectual property, rights of publicity, rights of privacy, and any other claims or damages with respect to such use or other exploitation. You affirm that You are of legal age and have read the foregoing release and fully understand its contents.

8. Forward Looking Statements

Prodalim may make or present forward-looking statements regarding its future events or future financial performance, or future events or future financial performance of its affiliated companies or partners. Words such as "expects", "goals", "plans", "believes", "continues", "may", and variations of such words and similar expressions identify forward-looking statements. In addition, any statements that refer to or may imply future financial performance, anticipated growth and trends in Prodalim businesses, and other characterizations of future events or circumstances are forward-looking statements. All such statements that are not historical facts are based on Prodalim's current expectations and are subject to a number of risks and uncertainties, and the actual events or results may differ materially.

9. Payments

Event fees and other charges may apply to Your attendance of or participation in any Event, or may otherwise be incurred by You in connection with an Event. If payment of any fees or charges is required, You may be asked to supply certain relevant information, such as Your credit card number and its expiration date, Your billing address and Your shipping information. You represent and warrant that You have the right to use any credit card for which You provide any credit card information in connection with a payment transaction. By submitting such information, You grant to Prodalim the right to provide such information to third parties for purposes of facilitating payment transactions. Verification of information may be required prior to the acknowledgment or completion of any payment transaction. Payments made for one Event may not be applied toward the purchase of any other Event, product or services. While it is Prodalim's practice to confirm Event-related payment transactions by e-mail, the receipt of an e-mail confirmation does not constitute acceptance of an order or confirmation of an offer to sell a product or service.

You acknowledge and agree that Your attendance of and participation in any Event or any related activities is completely voluntary and shall be at Your sole risk. Prodalim does not guarantee admittance to all or any part of any Event (including any session, keynote or other activity). Unless specified otherwise by Prodalim, all event sessions, keynotes or other activities, if applicable, are seated on a first-come, first-served basis. The Events and any materials and/or information provided therein are provided on an "AS IS" and "AS AVAILABLE" basis. You are solely responsible for any and all acts or omissions made by You in reliance on any Event (or any related activities) and/or any materials and/or information provided therein. To the fullest extent permitted by law, Prodalim, its officers, directors, employees, consultants, shareholders, representatives and agents disclaim all warranties, explicit or implied, in connection with the Events and any materials and/or information provided therein, and Your attendance of and participation in any Event, including implied warranties of merchantability, title, fitness for a particular purpose or non-infringement, usefulness, authority, accuracy, completeness, and timeliness.

You agree that Your attendance of and participation in any Event or any related activities shall be at Your sole risk. To the fullest extent permitted by law, Prodalim, its officers, directors, employees, consultants, shareholders, representatives and agents disclaim all warranties, explicit or implied, in connection with the Events and Your attendance of and participation in any Event, including implied warranties of merchantability, title, fitness for a particular purpose or non-infringement, usefulness, authority, accuracy, completeness, and timeliness. Prodalim makes no warranties or representations about the accuracy or completeness of the content of any Event, of the content of any sites linked to any Event, of any Third Party Materials (as defined below) and assumes no liability or responsibility for any:
